Colorado Association of Home Builders 2024 Voter Guide

Election Day is right around the corner, and that means the Colorado Association of Homebuilders has put together a voter guide for its members. Ballots should start arriving as early as this Saturday, and for most of us, our ballots will be lengthy with choices from U.S. president all the way to local ballot questions. When you take a look at your State of Colorado Blue Book, you will see 14 different statewide questions ranging from changing how primaries work for legislative races to banning trophy hunting. While the CAHB Government Affairs Committee did not take a position on any ballot questions, we recommend that you review the Blue Book and other sources.

As for candidates for the General Assembly, the association through its Executive Committee, Government Affairs Committee, and Political Funding Committee have reviewed candidates and ballot issues and engaged on statewide politics to provide insight and direction for our industry and our members. The 2024 Voting Guide summarizes that work and provides the CAHB's official position on endorsements in U.S. House races and state Senate and House contests. Many of the endorsements for the General Assembly weighted heavily on a candidate's willingness to support construction-litigation reform and other legislation critical to our industry and our goal of providing more housing choices to meet Colorado's housing needs.

Please utilize the 2024 Voter Guide as you fill out your ballot. We have also included an explanation of how the CAHB, working with its committees, selects candidates to support. Please also review this as you consider your ballot choices. Both documents can also be found on our website.

The CAHB will keep you updated on these political races and their outcomes, especially how they will impact the building industry moving into the 2025 legislative session.
